

# VIRTUS & FINGERPRINTING



All families must complete service hours. In order to volunteer at school and parish events (lunch duty, field trips, fundraisers, etc.), parents are required by the Archdiocese to take a VIRTUS® training course and be fingerprinted. There is no charge for either of these.

VIRTUS® Protecting God's Children Adult Awareness Session is a 3-hour training that helps clergy, staff, and volunteers to understand the facts and myths about child sexual abuse; how perpetrators operate; and how caring adults can take five important steps to keep children safe.

## VIRTUS®

- The Office of Safeguard the Children is sponsoring a series of VIRTUS® Zoom Sessions through September 2021. To register:
  - Complete the "Zoom Protecting God's Children VIRTUS® Session" & "Warning Agreement" forms.
    - If you have never attended a VIRTUS® session, be sure to select a date for the 3-hour "Protecting God's Children" session. The "Keeping the Promise Alive" session is only for those renewing VIRTUS® certification.
    - Note: Sessions are limited to 40 participants and are on a first-come basis.
  - Return both forms to Brenda Cabrera at [bmelendez@la-archdiocese.org](mailto:bmelendez@la-archdiocese.org).
  - Once Brenda receives your request, she will email you a confirmation with your Zoom session details.

Please note: You will need to renew your VIRTUS® certification every FOUR YEARS, either through reading short online articles every month and requesting an automatic recertification OR attending a 90-minute Keeping the Promise Alive session.

PLEASE BRING A COPY OF YOUR VIRTUS® CERTIFICATE TO THE SCHOOL OFFICE. WE KEEP THESE FORMS ON FILE AS PROOF THAT OUR STAFF & VOLUNTEERS ARE IN COMPLIANCE.
